All dogs will receive our personal care and attention in accordance with professional standards.

All dogs will be shown by me except when circumstances arise beyond my control, in which case, I will be replaced by another competent handler of my choice. Regular fees will apply. Handling fees will be charged unless the entry is withdrawn by the client and we have been notified in writing (email acceptable) prior to the entry closing date(s).

Statements are sent out at the end of the month via email. Statements are due and payable by the 5<sup>th</sup> of the following Month. Any accounts delinquent over 30 days will be assessed 15% of the total bill, monthly, until paid in full. A \$25.00 fee, as well as any other charges incurred, will be added to any NSF checks. No dog shall be released until all fees have been paid in full or as noted by special arrangement. Ribbons and awards, other than cash, will be sent out as soon as possible. Cash Awards will be retained by the handler.

Any litigation concerning this contract or damages for its breach shall be dealt with in Bossier Parish, Louisiana.
